The SHADES Summer PreK/Kind program is a full-time 9 week program operating from 7:30am to 6:00pm Monday through Friday from May 28, 2024 through July 24, 2024. Because SHADES is partially funded by a 21st Century Community Learning Grant, participants are required to attend at least 8 out of the 9 weeks. Participants are responsible for any applicable parent fees for all 9 weeks unless a week of vacation is requested. Participants that request a week of vacation are responsible for 8 weeks of parent fees. Please select the week you plan to take vacation below. Students must attend all other weeks. All participants must complete a financial assistance form and show proof of DHS Childcare Voucher program denial to be eligible for financial assistance.

SHADES serves 3 - 5 year olds who are potty trained in the PreK/Kind Summer Camp Program.

**Summer Fees**

SHADES cost of service is \$130.00 per week, per child for 5 day weeks; \$115.00 per week, per child for 4 day weeks; and \$100.00 per child for the week of July 22-24, 2024.

The first step to registering is pre-registration through MyProcure. Families pre-registered will be contacted to attend an orientation. A deadline to completed and submit orientation, paperwork and any applicable fees will be given. Failure to adhere to the deadline will forfeit your child's space and the next family on the pre-registration list will be contacted.

Deposits will be applied to the last week of fees. Registration fees and deposits are non-refundable. Weekly fees are due on Monday beginning the first week of summer.

**Scholarships**

*Scholarship funding is available for students attending 30 days or more. Participants receiving scholarship funding that fail to attend scheduled days per week may be in jeopardy of losing scholarship funding. Scholarships are awarded based on a priority rubric and sliding fee scale. All participants applying for scholarships must first apply for DHS voucher funding through Families First. If you do not qualify for DHS voucher funding SHADES will provide services based on a sliding fee scale while funds last. Families requesting funding that do not provide proof of application for DHS voucher funding will have a minimum of a \$10.00 per child/per week fee.*
