Scholarships

Scholarship funding is available for families with 3-5 year olds born on or before August 15 participating in Plan A (5 days per week) unless dictated to attend fewer days by an IEP. Participants receiving scholarship funding that fail to attend scheduled days per week may be in jeopardy of losing their space and/or scholarship funding. Scholarships are awarded based on a prioity rubric and sliding fee scale. All participants applying for scholarships must first apply for DHS voucher funding through Families First or other state voucher programs. If you do not qualify for DHS voucher funding SHADES will provide services based on a sliding fee scale. Families requesting funding that do not provide proof of application for DHS voucher funding will have a minimum of a \$10.00 per child/per week fee.
