Afterschool PreK Programming Available

SHADES Extended Learning PreK program is an eligibility-based program. Please complete all required documents to help us determine your child's eligibility to participate. Fees are based on a sliding scale per the SHADES Eligibility Selection Rubric. Eligible families will be contacted after completing the pre-registration link through MyProcure to complete the registration process. *Sibling discounts are not valid with any other tuition discounts.*

Please Note: You will be contacted from the MyProcure waiting list at which time you will have 48 hours from contact to secure your child's space in the program. Deposits will be applied to the last week of fees. Registration fees and deposits are non-refundable. Any applicable weekly fees are due the first day SHADES of Development.

Scholarships

Scholarship funding is available for families with 3-5 year olds born on or before August 15 participating in Plan A (5 days per week) unless dictated to attend fewer days by an IEP. Participants receiving scholarship funding that fail to attend scheduled days per week may be in jeopardy of losing their space and/or scholarship funding. Scholarships are awarded based on a priority rubric and sliding fee scale. All participants applying for scholarships must first apply for DHS voucher funding through Families First or other state voucher programs. If you do not qualify for DHS voucher funding SHADES will provide services based on a sliding fee scale. Families requesting funding that do not provide proof of application for DHS voucher funding will have a minimum of a \$10.00 per child/per week fee.
