The SHADES Summer PreK program is a full-time 8 week program operating from 7:30am to 6:00pm at Ft. Sanders PreK, Monday through Friday from May 26, 2026 through July 17, 2026. Participants are required to attend all 8 weeks of summer in order to qualify for sliding scale scholarships. Participants are responsible for any applicable parent fees for all 8 weeks regardless of attendance. SHADES has a limited amount of scholarship funds. All participants must complete a financial assistance form. Any participant in need of financial assistance must first apply for the DHS childcare voucher certificate program and receive a denial letter from DHS to be considered to receiving SHADES scholarship funds. Once scholarship funds are exhausted, DHS Childcare Vouchers are the only remaining form of financial assistance.

SHADES serves potty trained 3 - 5 year olds in the PreK Summer Camp Program. Three year olds must have previously attended Prek to be eligible to attend the SHADES PreK Summer Camp.

**Summer Fees**

SHADES cost of service is \$140.00 per week, per child for 5 day weeks; \$125.00 per week, per child for 4 day weeks.

The first step to registering is pre-registration through MyProcure. Families pre-registered will be contacted to attend an orientation. A deadline to completed and submit orientation, paperwork and any applicable fees will be given. Failure to adhere to the deadline will forfeit your child's space and the next family on the pre-registration list will be contacted.

Registration fees and deposits are non-refundable, however, deposits will be applied to the last week of fees for accounts in good standing. Weekly fees are due on Monday beginning the first week of summer.

**Scholarships Limited** scholarship funding is available for students attending 90 hours or more during the summer. Participants receiving scholarship funding that fail to attend regularly (90 hours or more) may be in jeopardy of losing scholarship funding. Scholarships are awarded based on a priority rubric and sliding fee scale. All participants applying for scholarships must first apply for DHS voucher funding through Families First. If you do not qualify for DHS voucher funding SHADES will provide services based on a sliding fee scale while funds last. Families requesting funding that do not provide proof of application for DHS voucher funding will have a minimum of a \$10.00 per child/per week fee added to their parent fee. (Not to exceed non-scholarship rates)
