When participating in the staggered week program you are reserving 10 days of care for a total cost of \$280.00 per child. Payment is due in full upon registration for staggered day services. Upon approval the staggered days may be paid in two equal payments with the first payment being due upon registration, along with applicable registration fees and Fall deposit fees. The second payment being due on August 10, 2025. Fees are due in full regardless of attendance. Please complete a change of service form two weeks in advance if your service needs change prior to the first day of school. Fees are due regardless of attendance unless a two-week notice is received not later than 6:00pm on July 27, 2026.

All other SHADES policies, terms, conditions and registration processes outlined in the SHADES Parent Handbook, orientation and licensing standards apply to the staggered week program. Spaces are limited. This document must be completed, signed and submitted with school-year registration to secure your child's space during staggered days.

Things to know about staggered days

- SHADES will pick your child up from Karns campuses only on your child's staggered day.
- *If your child attends a school other than Karns, transportation on staggered days is your responsibility and your intention to attend SHADES after your child's staggered day must be communicated and coordinated with the Karns Director by August 3, 2026.*
- Pack a lunchbox stable lunch and drink each day during the staggered days.
- SHADES will provide a morning and afternoon snack each day.
- Children should wear tennis shoes each day.
