SHADES Extended Learning afterschool program is an eligibility-based program. Please complete all required documents to help us determine your child's eligibility to participate. Fees are based on a sliding scale per the SHADES Eligibility Selection Rubric. Eligible families will be contacted after completing the pre-registration link through MyProcure to complete the registration process. Sibling discounts are not valid with any other tuition discounts. *Scholarship funding for LEAPS programs is contingent on the successful renewal of the LEAPs grant application.*

Plan A (Full Week Service 5 days per week)

Participants must enroll in the "5 days per week" Plan A program to receive financial assistance through grant funded scholarships.

Plan B (Three Day a Week Program) The 3 days selected must be the same 3 days each week. To attend days outside of the schedule you indicate below, you must sign up for the drop-in program, make a reservation and pay drop-in rates for those days. The three-day a week program is not eligible for scholarship funding.

Plan C (Two Day a Week Program) The two days selected must be the same two days each week. To attend days outside of the schedule you indicate below, you must sign up for the drop-in program, make a reservation and pay drop-in rates for those days. The two-day per week program is not eligible for scholarship funding.

Please Note: You will be contacted from the MyProcure waiting list, at which time you will have 48 hours from contact to secure your child's space in the program. Failure to complete and submit registration information, any applicable fees, and orientation, will forfeit your child's space, and you will be moved to the end of the waiting list.

Deposits will be applied to the last week of service. Registration fees and deposits are non-refundable. Weekly fees are due on Monday the first week of attendance.

Scholarships

Scholarship funding is available for families participating in Plan A (5 days per week). Participants receiving scholarship funding that fail to attend 5 days per week may be in jeopardy of losing scholarship funding. Scholarships are awarded based on a priority rubric and sliding fee scale. All participants applying for scholarships must first seek eligibility to receive DHS voucher funding through Families First or other state voucher programs. If you do not qualify for DHS voucher funding SHADES will provide services based on a sliding fee scale. Eligibility can be quickly assessed through Benefits Kitchen by texting "benefits" to 211-211 and complete a few questions. Families requesting funding that do not provide proof of application for DHS voucher funding will have a minimum of a \$10.00 per child/per week fee.
